Oireachtas Update



In Dáil Éireann on Tuesday afternoon and Wednesday morning, the Finance Bill 2014 is under discussion.

In the Seanad, there will be motions regarding the banking inquiry on Wednesday. On Tuesday afternoon, there will be statements on water sector reforms with the Department of the Environment, Community and Local Government.

The Social Welfare Bill 2014 will be discussed by the Joint Committee on Social Protection on Wednesday afternoon and Thursday morning. An overview of the banking sector in Ireland will be on the agenda for Wednesday afternoon in the Joint Committee on Finance, Public Expenditure and Reform.

Water Charges

A number of key plans regarding water charges have been announced by Alan Kelly TD, Minister for the Environment, Community and Local Government. Among the announced measures is the plan that water charges for a single-adult household will be capped at €60 and a family will face a maximum charge of €160 per year for the next four years.

It has also been announced that the starting date for water charges has been pushed back to 1st January 2015 with the first water bills to issue to households from April 2015. Houses that are not permanently occupied will face a minimum charge of €125 per year and up to a cap of €250.

Debate today on motion of no censure against Juncker

The 28 new European commissioners will travel to the European Parliament in Strasbourg today to debate the motion of no censure against Jean-Claude Juncker. Since at least one in ten members of the full parliament must back such a motion in order for a vote to be held, the collection of 76 signatures has dictated that the vote must take place, which will happen this Thursday November 27th at noon.

The motion of no censure was tabled last week by the Europe of Freedom and Direct Democracy (EFDD) group, which is chaired by Nigel Farage, leader of the United Kingdom Independence Party (UKIP). The motion states that Juncker, formerly Prime Minister of Luxembourg for 18 years, should not serve as President of the European Commission as *'aggressive corporate tax avoidance schemes in EU member states, particularly the one applied in the Grand Duchy of Luxembourg, have caused the loss of billions of euros in potential tax revenues to the other EU member states'*. Signatories include MEPs from the British UKIP, the French National Front and Italy's Five Star Movement. The motion is not expected to pass as the majority of other groupings are not expected to support it.

European Commission's 'Partnership Agreement' with Ireland

European Commission has agreed to a "Partnership Agreement" with Ireland. This agreement is focused on the best possible use of European Structural and Investment Funds in Ireland. In total there will be €3.357 billion in European Structural and Investment Funds over the period 2014 to 2020. Investment will be channelled through the European Regional Development Fund, European Maritime and Fisheries Fund, European Social Fund, Youth Employment Initiative and the European Agricultural Fund for Rural Development.

The aim of the funding is to contribute to tackling unemployment and help to boost economic growth and competitiveness. This will be done through support set aside for education, training and innovation in a bid to also promote entrepreneurship, be an environmentally friendly economy and to combat social exclusion.

Apprenticeship Council Announced

A new Apprenticeship Council has been established and announced by Jan O'Sullivan TD, Minister for Education and Skills and Damien English TD, Minister of State with Special Responsibility for Skills, Research and Innovation. The foundation of this Apprenticeship Council is a result of a review of the Apprenticeship System in Ireland which was a part of the Governments Action Plan for Jobs initiative. This review recommended that an Apprenticeship Council should be founded. The new Apprenticeship Council is tasked with expanded the apprenticeships system into new areas of the Irish economy and industry.

Pat O' Doherty, CEO of ESB, has been named as Chairman of the Apprenticeship Council.
